Finance company officer with 2 or more years of continuous service	Marriage celebrant registered under Subdivision C of Division 1 of Part IV of the Marriage Act 1961
Member of the Association of Taxation and Management Accountants	Member of Engineers Australia, other than at the grade of student
Teacher employed on a full-time basis at a school or tertiary education institution	Member of the Australasian Institute of Mining and Metallurgy
Minister of religion registered under Subdivision A of Division 1 of Part IV of the Marriage Act 1961	Person before whom a statutory declaration may be made under the law of the State or Territory in which the declaration is made
An officer with, or authorised representative of, a holder of an Australian financial services licence, having 2 or more years of continuous service with one or more licensees.	Member of the Institute of Chartered Accountants in Australia, the Australian Society of Certified Practising Accountants or the National Institute of Accountants.
Employee of the Australian Trade Commission who is: <ul style="list-style-type: none"> a) in a country or place outside Australia; and b) authorised under paragraph 3 (d) of the Consular Fees Act 1922; and c) exercising his or her function in that place.
